

H-SAA AMENDING AGREEMENT

THIS AMENDING AGREEMENT (the “Agreement”) is made as of the 1st day of April, 2018

B E T W E E N:

NORTH SIMCOE MUSKOKA LOCAL HEALTH INTEGRATION NETWORK
(the “LHIN”)

AND

GEORGIAN BAY GENERAL HOSPITAL
(the “Hospital”)

WHEREAS the LHIN and the Hospital (together the “Parties”) entered into a hospital service accountability agreement that took effect April 1, 2008 (the “H-SAA”);

AND WHEREAS pursuant to various amending agreements the term of the H-SAA has been extended to March 31, 2018;

AND WHEREAS the LHIN and the Hospital have agreed to extend the H-SAA until June 30, 2018 to: i) permit the Hospital to obtain the necessary approvals of the Hospital board to allow the Hospital to enter into the attached Hospital Service Accountability Agreement for 2018-20 (the “new H-SAA”); and, ii) allow the LHIN and the Hospital to finalize schedules for the 2018-19 Fiscal Year to replace the Schedules (the “New Schedules”);

NOW THEREFORE in consideration of mutual promises and agreements contained in this Agreement and other good and valuable consideration, the parties agree as follows:

- 1.0 Definitions.** Except as otherwise defined in this Agreement, all terms shall have the meaning ascribed to them in the H-SAA. References in this Agreement to the H-SAA mean the H-SAA as amended and extended.
- 2.0 Amendments.**
- 2.1 Agreed Amendments. The H-SAA is amended as set out in this Article 2.
- 2.2 Hospital Board Approval of New H-SAA. The Hospital will seek the necessary approval of its board to enable the Hospital to promptly enter into the new H-SAA.
- 2.3 Hospital to Sign New H-SAA. Promptly upon receiving the necessary approvals of the Hospital's board, the Hospital will duly execute the new H-SAA and return the duly executed new H-SAA to the LHIN.
- 2.4 Termination of H-SAA. The H-SAA shall terminate immediately upon the new H-SAA coming into effect.
- 2.5 Schedule Definition Amended. The definition of Schedule is amended to include the attached Supplementary Schedule AA.
- 2.6 Schedules under New H-SAA. The Schedules will be the Schedules for the purposes of, and as defined in, the new H-SAA, immediately upon the new H-SAA coming into effect.
- 2.7 New Schedules. Upon agreement of the Parties, the new Schedules shall replace the Schedules for purposes of the H-SAA or the new H-SAA, whichever is in effect at the time of the Parties agreement.
- 2.8 Term. This Agreement will terminate June 30, 2018.
- 3.0 Effective Date.** The amendments set out in Article 2 shall take effect on April 1, 2018. All other terms of the H-SAA shall remain in full force and effect.
- 4.0 Governing Law.** This Agreement and the rights, obligations and relations of the Parties will be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.
- 5.0 Counterparts.** This Agreement may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.
- 6.0 Entire Agreement.** This Agreement constitutes the entire agreement between the Parties with respect to the subject matter contained in this Agreement and supersedes all prior oral or written representations and agreements.




